Overview

- Approximately \$322 million is available through this Special NOFO (\$267,500,00 for the Unsheltered Homelessness Set Aside)
- MDHI can apply for up to \$13,334,264 for a three-year grant term
 - Roughly \$4 million a year
 - This includes CoC Planning, HMIS and CE
 - Unlike the normal Program NOFO these funds are not guaranteed
- ❖ Project applications must be submitted to the CoC and all projects must be rated and ranked on the CoC Priority Listing.
- ❖ The deadline is October 20th with project applications due September 16th

Selection Criteria

- ☐ HUD will select a CoC's projects for funding based on CoC Score
 - □ CoC Consolidated Applications will be assessed on a 100 point scale and CoCs must receive at least 50 points to be considered for any funding under this Competition
 - □Unsheltered Homelessness Bonus points Based on 2019 PIT unsheltered count. Our CoC doesn't qualify for any of these points as our count was under 1,000 (946)
 - Also accounting for "Geographic Representation"
 - Only 10 CoCs in each state, even if they score higher than others, can be awarded
- ☐ The Consolidated Application is made up of 4 scoring sections
 - Project Capacity, Review and Ranking (4 points)
 - □ System Performance (18 points)
 - □ CoC Coordinated and Engagement (8 points)
 - □ CoC Plan for Serving Individuals and Families Experiencing Homelessness with Severe Service Needs (70 points)

Getting Started

HUD will review each program application and even if the CoC recommends a program for funding, HUD may reject it. Please ensure the following:

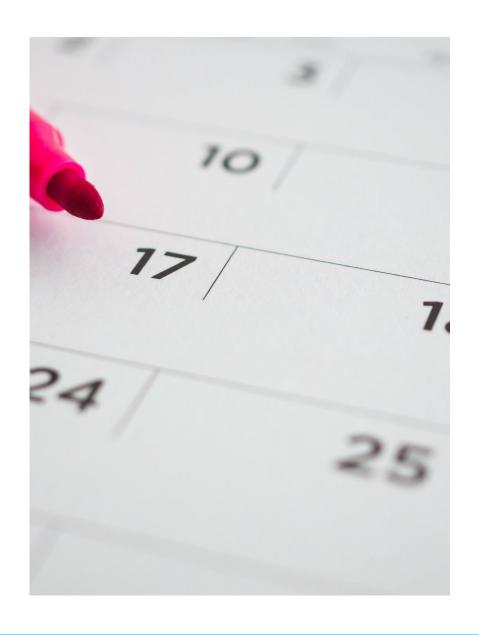
- 1. all proposed program participants will be eligible for the program component type selected,
- 2. the information provided in the project application and proposed activities are eligible and consistent with program requirements in the Rule;
- 3. each project narrative is fully responsive to the question being asked and that it meets all the criteria for that question as required by this NOFO;
- 4. the data provided in various parts of the project application are consistent; and
- 5. all required attachments correspond to the list of attachments in e-snaps that must contain accurate and complete information that are dated between June 22, 2022 and October 20, 2022.

Eligible Project Types

- Permanent Housing
 - ➤ Permanent Supportive Housing (PH-PSH)
 - Permanent Housing Rapid Re-housing (PH-RRH)
- ► Joint TH and PH-RRH
- ➤ Supportive Service Only
 - ➤ Coordinated Entry (SSO-CE)
 - ➤ Street Outreach (SSO-SO)
 - >Standalone SSO
- > HMIS
- ➤ CoC Planning

Project Requirements

- ✓ All projects must adopt and follow a Housing First approach
- ✓ All projects must pass eligibility and quality thresholds outlined in the NOFO
- ✓ All applicants must demonstrate, in their project application, how they are consistent with the CoC's Plan for Serving Individuals and Families Experiencing Homelessness with Severe Service Needs
- ✓ Projects can not currently be funded through CoC or ESG funds
- ✓ Any project containing a request for acquisition, new construction, or rehabilitation funds will be rejected.



Important Dates

- August 12th: Letters of Intent Due
- OAugust 19th: Unsheltered Plan Feedback Due
- OSeptember 16th: Project applications submitted to CoC
- October 5th: CoC notifies project applicants about whether their application will be accepted and ranked, rejected, or reduced
- October 18th: CoC posts online all parts of the Special NOFO Consolidated Application for public viewing
- October 20th: Submission Deadline
